PLEASE PAY ATTENTION

Editors of this newsletter have been addressing the problem of motorists disregarding traffic laws in Magnolia Forest for at least the past five years. The two main issues have been ignoring stop signs and speeding. A few years back we began using paid patrols, and for a long period of time (in most cases) residents of Magnolia Forest were only given a warning. Also, within the last couple of years, we have had a board member monitor the neighborhood and suggest to the deputy where there may be the largest number of problems.

The above did improve the situation; however, recent reports that we received from residents indicate that this has not been enough. In addition to having cyclists run off the road, we also had a report of a near miss of a child. In another case a concerned neighbor approached a speeding neighbor.

Things are about to change. We, as a board, have unanimously agreed that we would rather be proactive than reactive. In other words, we would rather hear you complain about receiving a traffic citation, than hear about what just happened. Therefore, be forewarned that beginning in June, the patrol times will significantly increase, and at certain times the patrols may be doubled. In addition, there will be no more warnings for residents. If you are caught by one of our patrols for violating a traffic law in Magnolia Forest, you will be ticketed.

Let me repeat. If you are caught by one of our patrols for violating a traffic law in Magnolia Forest, you will receive a traffic citation (ticket). There will be no more warnings.

Please note: Off-road vehicles (all-terrain and golf carts) are illegal on public roads. If a motorized vehicle does not have a license plate, it is illegal. It has also been reported to us that pre-teens have been spotted driving golf carts in our neighborhood.

In addition to the above, Pete Giuffria, Board President, has been in contact with our Councilman Gene Bellisario to request that additional traffic signs be placed in some areas, and also the possibility of speed bumps. If you know where there is a missing sign, or can identify where a sign may be beneficial, please contact Pete. Pete's contact information is listed in the left hand column of this newsletter.

Our representative on the board who coordinates with the Sheriff's Office is **Louis (LJ) Deris.** Louis doesn't just simply call and schedule patrols. He actually discusses with the deputy where the complaints are coming from, the hours of work, best days, etc. As a hint, most of our reported violations have been on the main thoroughfares: Fischer, Morgan Bluff, Oak Alley, Parlange.

If you have any concerns/suggestions regarding any of the above, Louis will welcome your call. All of his contact information is listed in the left hand column of this newsletter.


> Georgie is the daughter of Jim and Dana Fatic and granddaughter of LJ and Beryl Deris, all residents of Magnolia Forest.
