### Magnolia Facts (Hope You Enjoy)

Magnolia trees are an ancient tree, appearing before bees. It is theorized that the hard carpels of the magnolia flower developed to avoid damage from pollination by beetles over 20 million years ago. Some plants belonging to the magnolia family date back to 95 million years ago.

The name magnolia first appeared in 1703 by an English botanist who named it after Pierre Magnol, a French botanist that organized the classification of plant families based on morphological characteristics. The family name is *Magnoliaceae* and contains over 200 species. Magnolias can be evergreen or deciduous and have been naturalized to all continents in the world, except Antarctica, because of their beauty and fragrant blossoms.

The Magnolia trees that we are most familiar with locally are the southern magnolia (*Magnolia grandiflora*) and sweetbay magnolia (*Magnolia virginiana*). Both are native to the Southeastern United States. Southern magnolias can grow to heights of about 80 ft. They produce 12-inch blossoms and occur in upland areas and can handle dry periods while also tolerant of high moisture levels. Sweetbay magnolias grow up to 50 ft tall and their blossoms are significantly smaller, about 2 to 3 inches in diameter. They prefer moist areas and need constant moisture to grow well. If you need a smaller magnolia for your yard, the "Little Gem" dwarf magnolia that will grow to 12 to 20 feet and produce smaller flowers.

In 1900, school children from Mississippi voted the southern magnolia as the state flower, beating out the cotton blossom and cape jasmine, and the state tree in 1938. The Mississippi state legislature made it official in 1952. Louisiana designated the magnolia as the official state flower in 1900.

Asian countries use their magnolia trees in different manners. Traditional Chinese medicine uses the bark and flower buds (*Magnolia officinalis*) for anti-anxiety and anti-carcinogenesis properties. Magnolia bark contains bioactive compounds that function as anti-inflammatory, anti-bacterial, and anti-allergic agents. Some parts of Japan use the leaves (*Magnolia obovate*) for wrapping food and cooking dishes. The magnolia's red seeds are a delicacy for squirrels, quail, and other wildlife. Lumber harvested from southern magnolia trees is used to make furniture and veneers due to its hardness and density.

Magnolia trees can be so much more than just an ornamental beauty!
