# MAGNOLIA FOREST HOMEOWNERS ASSOCIATION ANNUAL **GENERAL MEMBERSHIP MEETING**

Thursday, December 9, 2021 at 7 pm **Generations Church** 62340 Hwy 1090 (N. Military Road)

Current board members Bob Meltz, Peter Giuffria, Gina Nash, Paul Rao, Tracie Sheffield, and Pam Howell are willing to remain on the board for 2022. We have nominations for Lynn Adams, Terry Becnel and Jim Griswold as new board members.

In keeping with our by-laws, any member of this association may place a candidate on the slate; however, this must be given to the nominating committee 30 days prior to the 4th quarter general membership meeting, on December 9<sup>th</sup>, when the election will be held. If you would like to be nominated for a position on the board or recommend someone, please contact any board member listed on the front of this newsletter by November 9<sup>th</sup>.

We will also be voting on a by-laws change. Article 5, Section E of the by-laws currently reads:

A quorum of the Board of Directors shall consist of five (5) directors. The President shall not be eligible to vote except in the case of a tie, at which time he must vote to break the tie.

The board recommends changing this to:

A quorum of the Board of Directors shall consist of five (5) directors, assuming there are 8 or 9 directors. If there are 6 or 7 directors, a quorum shall consist of 4 directors. If there are 4 or 5 directors, a quorum shall consist of 3 directors. The President shall not be eligible to vote except in the case of a tie, at which time he must vote to break the tie.

Reasoning: The original by-law assumed 9 directors. With 9 directors, 5 is a quorum. We often have less than 9 directors. Requiring a quorum of 5 is not reasonable when working with less than 8 or 9 directors. This change gives the board the flexibility to define a quorum that is a function of size of the board.

Representative Mike Smith and Waste Management's Donald Hains will be guest speakers. We are also trying to get a representative from Utilities, Inc. Plus, each attendee receives a free ticket for the "entertainment" basket raffle!
