#### MFHA GENERAL MEETING 12/9/21

Despite the foul weather, our annual general meeting had a great turnout at **Generations Church**. We had about 30 association members in attendance.

**Bob Meltz** read through the proposed by-laws change, redefining what constitutes a quorum during board meetings (Article 5, Section E), which was approved unanimously by present members. The by-laws change was printed in the November 2021 newsletter and will be edited to reflect these changes in early 2022. **Paul Rao** reported that the year-end HOA membership was 212 and gave a draft summary of the treasurer's report. **Gina Nash** reported on the 2021 Social Committee's past activities, including the Easter Scavenger Hunt and the Halloween Hayride, and discussed upcoming events, like Santa Claus in a Convertible on December 18<sup>th</sup>. She also discussed how the MFHA Facebook page has helped with advertising our annual MFHA Yard Sale and keeping our neighborhood family up to date.

**Sergeant Casnave** spoke on the behalf of the St. Tammany Sherriff Office on a range of topics, from camera monitoring options for neighborhood entrances to golf carts and safety issues. Sergeant Casnave frequently does the police patrols in Magnolia Forest and observed numerous motorized vehicles on the streets in Magnolia Forest that were not "street legal". These motorized vehicles need to be insured, the driver needs to have a valid driver's license, and appropriate tags and lighting installed.

#### POLICE PATROLS & GOLF CARTS/ATVs

Magnolia Forest had a scheduled police patrol in late January that resulted in 7 traffic stops. All 7 were speed related, with 4 citations issued and 3 warnings given.

MFHA is scheduling numerous police patrols as we move into the Spring season, with increased pedestrian and bicycle traffic. The St. Tammany Parish Sherriff's Office received an increased number of complaints in 2021 about children recklessly driving golf carts and ATVs in our neighborhood, including golf carts wrecked in drainage ditches, near misses with pedestrians and running through stop signs into on-coming traffic.

The Sherriff's Office notified the Board that officers will start issuing citations and warnings for non-compliant motorized vehicles. Since the roads in our neighborhood are "public" streets, all motorized vehicles on Magnolia Forest streets need to be registered with the DMV with mounted license plate, appropriate headlights and brake lights installed, and suitable insurance. This will apply to vehicles driven by adults and minors.

Parents, please be aware that if your child's actions result in injury to a passenger or other person, you can be held financially and legally responsible. Numerous citations may result in the impoundment of the non-complaint motorized vehicle. So please, make sure your motorized vehicles are "street-legal" and be courte-ous of our pedestrian and bicycle traffic!
