Drainage

Now that a wetter weather pattern has returned, it's time to re-evaluate the health of our neighborhood drainage systems. Several culverts have become clogged with the accumulation of leaves and debris. If you're able, clean things out yourself. If your ditches or culverts need clearing, you also can call the "Parish Barn" at 863-5392 to have them inspected and/or cleaned, as well as street sign replacement and any other types of maintenance. Also, if you have a damaged culvert, contact the Barn so they can help you decide what size and type of culvert you will need to purchase and schedule an installation date.

Police Patrols, Golf Carts and ATVs

MFHA is scheduling numerous police patrols as we move into the Spring season, with increased pedestrian and bicycle traffic.
