President's Corner:

- **Street parking :** Our covenants do not permit on-street parking. We try to be reasonable in the enforcement of this covenant. If you are having an event at your house, and cars are parked on the street, we are not going to write you up. If, on the other hand, there consistently are vehicles parked on the street in front of your house, or vehicles are parked overnight on the street, we will probably get in touch with you. Most of us have long driveways. Use it for off-street parking.
- Your HOA at work: Back in early May some of you may have noticed the cabbie that ran off Military into one of our Fischer entrance flower beds. I was informed of this and went to the scene. Fortunately no one was hurt. I got the cabbie's insurance information and the MFHA was able to be completely financially reimbursed for over \$1600 in landscaping damages. Thanks to the Green Team for doing a great job restoring the landscaping.



- Please obey the parish-wide (actually state-wide) burn ban.
- **Open HOA board positions :** Three of our current board members will be stepping down at the end of 2023. I will be stepping down because of our 6 year term limit clause. Gina Nash and Tracy Sheffield will also be stepping down. Let me know if you have any interest in being on the board. We need to have all nominations by early November, and will vote new board members at our annual general membership meeting in December.
- Night out Against Crime event: The Sheriff's complex on Brownswitch will be hosting a Night Out Against Crime event on Tuesday, October 3rd. Look for more information on this event either via an email blast, or in our October newsletter.
- **Signs in yards:** Our covenants allow for For-sale signs in your yard. We have also allowed political signs. We don't allow business signs. So, please remove any business signs in your yard.

NEIGHBORHOOD DUMPSTER

As part of Magnolia Forest's contract with Waste Management, our annual roll-off container for residents' bulk trash disposal has been scheduled in conjunction with our Magnolia Forest Yard Sale. That way, as you are cleaning out your house for the yard sale, you can purge bulky items. The dumpster will be available Friday evening (Oct. 6) through Monday morning (Oct. 9). The dumpster will be located at the Magnolia Forest Stables at the end of Crowe's Landing Road.

Be courteous and walk your trash as far back as possible into the dumpster and please stack your trash to help maximize space for our entire neighborhood. When the dumpster is full, the gates to the stables will be locked. Please do not leave trash outside of the bin or outside the gate. We will have cameras monitoring the site and litterers will be held responsible for cleaning up the mess or reported to the Sheriff's Office.
