Weather Highlights from the April 10th storm

As per the National Weather Service, the storm system that came through on Wednesday, April 10th included 8 tornadoes. Below are some highlights from a story by Alex Lubben in the April 19th edition of The Advocate:

"Of the eight twisters, the strongest was the one that passed through Slidell, where it caused extensive damage to homes and businesses. On the scale of EFO to EF5, the Slidell twister was graded EF2, meaning it packed winds of up to 120 mph.

The three others that formed in Louisiana clocked winds between 85 and 100 mph and were graded EF0s and EF1s. Those passed through areas north of Slidell, through more rural areas near Pearl River and Alton. One crossed the Mississippi border and tracked over the Stennis Space Center into Hancock County, Mississippi."
