# **President's Corner:**

#### Proposal from Waste Management:

The negotiations with Waste Management are nearly complete.

These are the highlights of the new monthly rates:

\$21.49 Garbage Collection 96-gal Cart (Cart contents only) 2X per week

\$5.51 Recycling Collection 96-gal Cart (Cart contents only) every other week. All homeowners will be provided with a new 96 gallon cart for recycling.

Standard monthly fee = \$27.00

Extra if wanted – Second 96-gal Garbage Collection Cart \$10.00 (Cart contents only) 2X per week

Monthly fee with 2<sup>nd</sup> Garbage cart = \$37.00

WM will still provide the dumpster at the Magnolia Forest stables over the weekend of the annual yard sale (this year those dates are Friday, October 4<sup>th</sup> through Monday, October 7<sup>th</sup>).

### Toward a More Digital Future:

The HOA is considering moving to a more digital format for our monthly newsletter. We currently print over 350 copies and hand deliver them to all homeowners in Magnolia Forest. We also post the newsletter online, and email the newsletter to many.

One option under consideration includes replacing the hand delivery throughout the entire neighborhood with 2 newsletter mailboxes, one at the Oak Alley entrance and one at the Fischer entrance and putting 25 or so newsletters in each mailbox. The digital options will still be available. This will save on printing expenses, and also eliminate the need for newsletter delivery people. If you have feedback on this, let me know.

Toward that end, in our efforts for more effective communication, the HOA would like the email addresses of all of our homeowners who have email. If you have not been receiving the newsletter via email, it is because we don't have your email address.
