# MAGNOLIA FOREST HOMEOWNERS ASSOCIATION ANNUAL GENERAL MEMBERSHIP MEETING

Thursday, December 12, 2024 at 7 pm

Current board members **Terry Becnel, Carl Smith, Denny McDowell, Betty Rose and Peter Giuffria** are eligible to remain, and have agreed to remain, on the HOA board in 2025. **Carroll Knowles and L.J. Deris** will be rotating off the board. We have nominations for **Lisa Adams** and **Bob Meltz** as new board members for 2025.

In keeping with our by-laws, any member of this association may place a candidate on the slate; however, this must be given to the nominating committee (any current board member) 30 days prior to the 4th quarter general membership meeting, on December 12<sup>th</sup>, when the election will be held. Nominations from the floor are not allowed.

Parish councilman **David Cougle**, a representative from the St. Tammany Sherriff's Department, and Waste Management's **Donald Hains** have been invited as guest speakers. Plus, each attendee will receive a free ticket for the "entertainment" basket raffle!

# **IMPORTANT: Waste Management Recycling Vote**

All Magnolia Forest residents in attendance who are patrons of Waste Management, HOA members and non-members, will be asked to vote on whether or not Magnolia Forest will continue to have recycling.

- A vote for recycling means all Waste Management patrons will be charged \$5.50/month for once-every-2-weeks recycling pickup. You will be provided, at no charge, a 96 gallon recycling cart.
- A vote against recycling means no-one will be charged this additional monthly fee, and Magnolia Forest will no longer have recycling.

So, if we vote to have recycling, your monthly fee will be \$27.00. If we vote to not have recycling, your monthly fee will be \$21.49. Again, this assumes you have both paperless billing and autopay.

Some of you have already voted via email.

This will be decided by a popular vote— one vote per household.

# CHRISTMAS DECORATING CONTEST

Once again, the Magnolia Forest Garden Club will sponsor the subdivision Christmas decorating contest. This is a yearly tradition and is open to all residents of Magnolia Forest.

The judging will be Tuesday December 17<sup>th</sup>, between 6:00 PM and 9:00 PM by three judges appointed by the Garden Club. (In case of bad weather, judging will be done on the 18th.) Decorations will be judged from the inside of a car parked on the street with an adult point of view.

One winner in each category will be selected and awarded a gift, compliments of the Garden Club. There are no materials or color scheme restrictions. It is preferred that a homeowner not receive an award two consecutive years for the same category.

# Category 1 - Doors and/or Entrances

Cut glass, stained glass and carved doors need not have decoration, but the entire entrance effect is considered in judging.

# Category 2 - Artistic Home and Yard

Decorations may consist of wreaths, garlands, swags, candles, organized string lighting and/or spot lighting. Decorations must be well placed, in good taste and carry out an overall theme. If string lighting is used, it must support the overall design.

# **Category 3 - Novelty Home and Yard**

Decorations may consist of a novelty scene, angels, reindeer, sleigh, etc., spot lighting and/or string lighting. All items should be well placed in an organized manner with effective lighting where needed.

# Garden of the Month - October 2024

The home of Carroll and Lenny Knowles at 401 Ormond Drive was selected as Garden of the Month for October 2024 by judges Darlene Fuller and Betty Rose of the Magnolia Forest Garden Club. The branching pyracantha at the entrance is popping with orange berries, perfect for fall. A delight to view, as the berries will turn red for the coming holiday season. The garden bed under this bush has variegated Aztec grass and Encore azaleas. The neatly trimmed Japanese Yews, lorapetalums and azaleas in the bed to left of the entrance offers variations of color and texture. Also providing seasonal splashes of color are Camelias, Shi-Shi Sasanquas, and crepe myrtles. These plants surround the 3-tier fountain. The fountain gives an inviting sound of splashing water as if saying "Welcome to My Home".

# Garden of the Month - November 2024

The home of John and Charlotte Campbell located at 513 Hermitage Drive was selected as the November 2024 Garden of the Month for Magnolia Forest Subdivision. This home has a beautifully manicured lawn with native Oak and Pine trees. The garden was a stand out with seasonal Yellow Chrysanthemums. Other notable plants were Shishi Sasanquas, Indian Hawthorn, Sweet Olive, Sunshine Ligustrum, Juniper and Foxtail Fern.
